APPROXIMATELY 15 - 20 GRANTS ARE AWARDED ANNUALLY TO VETTED NONPROFIT PARTNERS IN GUATEMALA, MEXICO, AND BELIZE. REPRESENTATIVES OF THE FOUNDATION TRAVEL TO THESE AREAS PERIODICALLY TO MONITOR AND OBSERVE THE PROGRAMS AND REGULAR ONLINE MEETINGS ARE HELD WITH SUPERVISORS AND STUDENTS. MEF SERVES UP TO 500 MAYA STUDENTS PER YEAR IN THE VARIOUS SCHOLARSHIP PROGRAMS IT SUPPORTS.
